In accordance with the Low-Income Home Energy Assistance Act of 1981, the State of New York publishes a notice of intent to amend the 1993-94 New York State Plan for Low-Income Home Energy Assistance.

PROPOSED AMENDMENT: The current 1993-94 HEAP State Plan allocates fifteen (15) percent of the annual New York State LIHEAP allocation to support weatherization activities. The amendment under consideration is a proposal to allocate up to an additional \$10 million to NYS weatherization initiatives.

REVIEWING OR OBTAINING THE PROPOSED AMENDMENT TO THE STATE PLAN: The proposed amendment will be available for inspection at local department of social services' offices. Copies of the proposed amendment may be requested by calling, toll-free, 1-800-342-3009, extension 4-9321 or by writing to the Bureau of Energy Programs, New York State Department of Social Services, 40 North Pearl Street, Albany, New York 12243.

PUBLIC HEARING: A public hearing on the proposed amendment to the State Plan will be conducted on:

Pursuant to New York State (NYS) statute, NYS must set aside 15% of its annual LIHEAP allocation to support weatherization activities. Funding set aside for weatherization will be distributed as follows:

- o The NYSDSS will enter into a Memorandum of Understanding (MOU) with the NYS Department of State (DOS) to transfer fourteen (14) percent of the NYS FY 1994 LIHEAP allocation to DOS to support weatherization services through its Weatherization Assistance Program (WAP). DOS/WAP will utilize DOE guidelines with the exception that participation in the HEAP funded portion of DOS/WAP will not be precluded because of the receipt of prior weatherization services by the applicant household. On a case by case basis, where an energy audit or assessment identifies an additional weatherization need, further weatherization services may be provided. The DOS/WAP HEAP weatherization allocation will be sub-allocated and dedicated to the following specified activities:
 - oo 10% - DOS/WAP traditional weatherization activities.
 - oo 1% - To distributed by DOS to local departments of social services for weatherization packaging activities.
 - oo 1% - To be allocated for crisis furnace replacements. This crisis benefit will be provided through the DOS/WAP local subgrantee network.
 - oo 2% - To be dedicated to the targeted weatherization of LDSS-identified priority households. Priority weatherization services will be provided through the DOS/WAP subgrantee network.
- o The NYSDSS will enter into a MOU with the NYS Office for the Aging (SOFA) to transfer one (1) percent of the NYS FY 1994 LIHEAP allocation to SOFA for weatherization packaging activities.
- o An additional amount, not to exceed \$10M from NYS' 1993-94 supplemental appropriation will be utilized for the weatherization initiatives listed above. Since the additional funding will exceed the 15% statutory set aside limit, NYSDSS will obtain approval from HHS to effect the excess set aside.

NOTE: Any FY 1993 funding allocated for weatherization activities which was not obligated by 9/30/93 will be carried forward and earmarked for distribution, during FFY 1994, in a manner as intended and described in NYS' LIHEAP state plan for 1992-93 (FFY 1993).
