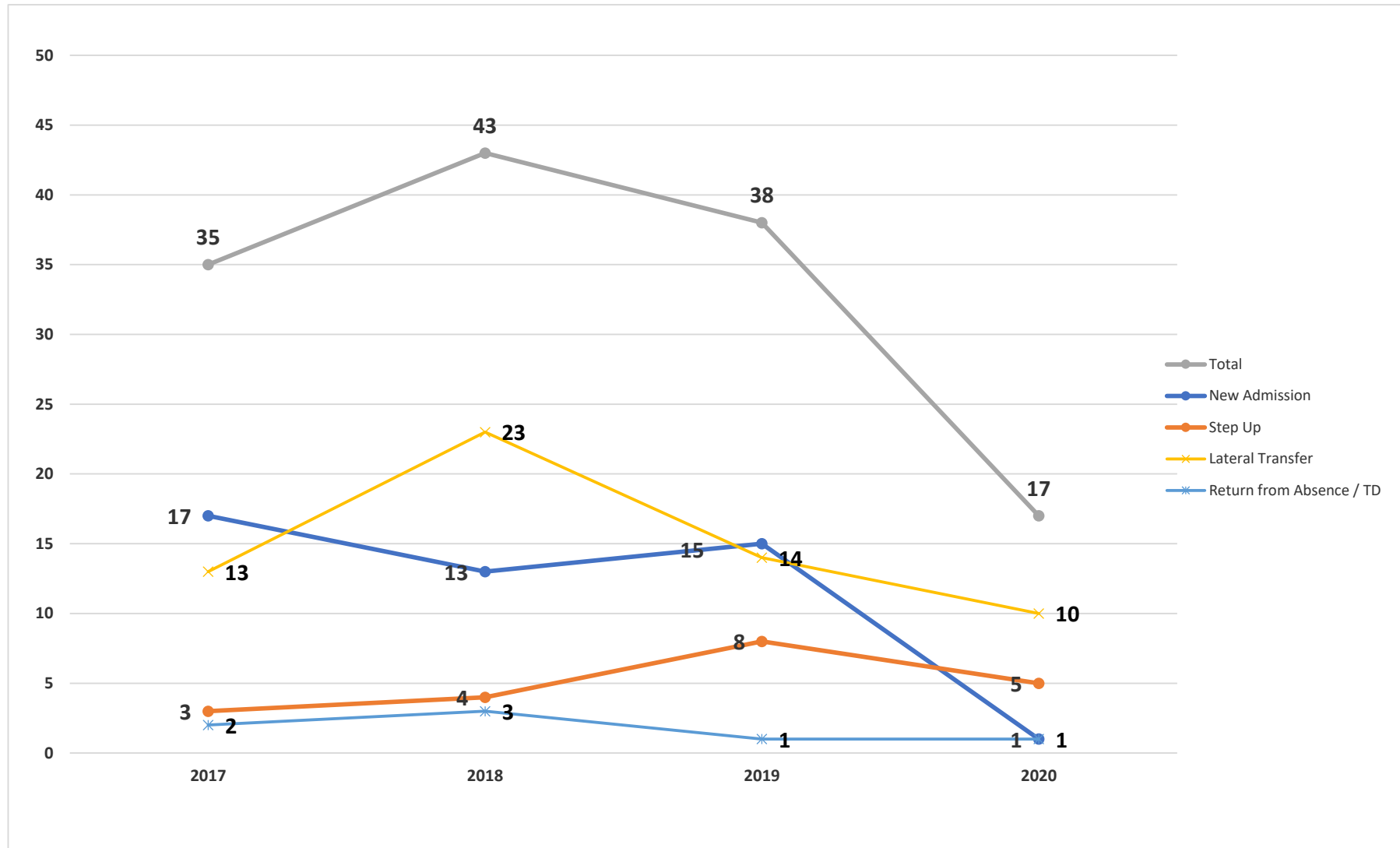

Figure 1. Movements into Congregate Care between 2017 and 2020, CHAUTAUQUA



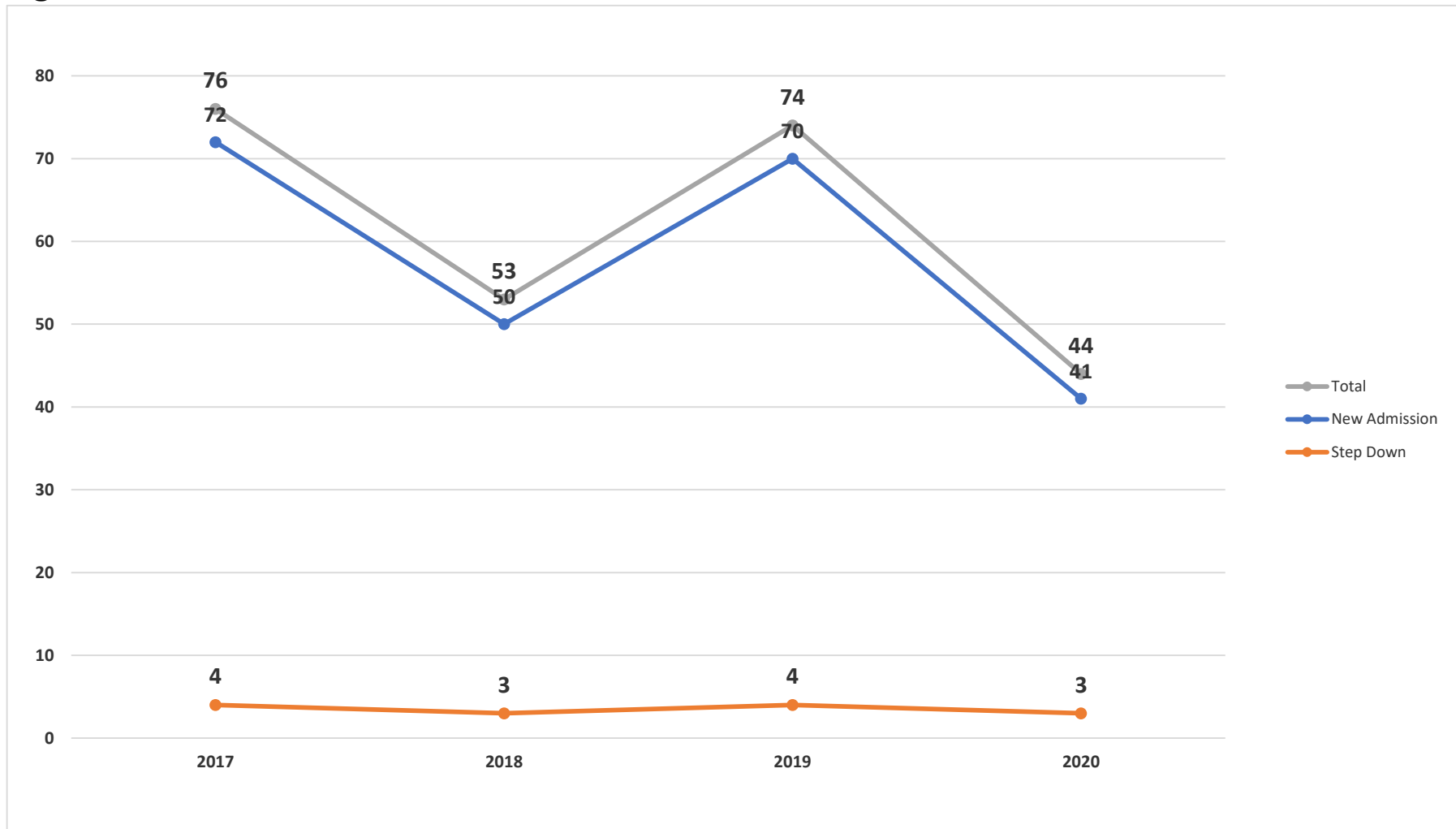
