Dear Chief Executive Officer,

Thank you for submitting **Putnam** County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2020-2021. Your entire STSJP plan, including any amounts listed for PY 2020-2021 STSJP-RTA, has been **approved.**

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2021, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP

Once the shift is approved, an amended STSJP plan will need to be submitted.

As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2020 to September 30, 2021. B. Municipality Level Analysis

- (a) Identify communities or neighborhoods from which the highest number of Youthful Offenders (YO), Adolescent Offenders (AO), Juvenile Offenders (JO), Juvenile Delinquents (JD), and Persons in Need of Supervision (PINS) enter the youth justice system, are remanded to detention, and/or are residentially placed; then (b) Discuss what factors may be contributing to these high numbers:

Putnam County Department of Social Services along with a Consulting Team did an analysis of our communities from which the greatest number of juvenile delinquents (JD) and persons in need of supervision (PINS) were remanded to detention during 2019-2020. Putnam County had 1 youth remanded to non-secure during 2019-2020.

Putnam County had one OCFS custody placements in the STSJP program year..
 Putnam County had one non-secure placed youth in the program year and three PINS youth were placed in 2019.
 Total JD probation intake cases opened for youth during program year in Putnam County was 23 and 34 PINS cases.
 These numbers are so low there is not enough cases to provide an analysis, since the prevention programs have been so strong that the data leaves us with insufficient data to provide a true analysis. Putnam County worked to have two year contracts in place and due to COVID-19 we will be have to re-evaluate our contract process.

Putnam County population is comprised of 79% White, 14% Hispanic, 3% Black and 2% Asian. Due to the low number of detention and residential placements in Putnam County, there are no known racial/ethnic disparities. In 2019, Putnam County had two youth admitted to detention.

 Even with COVID, Green Chimneys continued to be in touch with the youth who were in their program. They could not meet in person, so they touched base via phone and virtual meetings.

 Green Chimneys continues to meet all their goals. They did not receive as many referrals during the health crisis, but the number of youth who will need services will increase due to the shutdown and needing additional mental health services.

Green Chimneys had to quickly pivot during the health crisis. They were always in touch with the children and family in their progema, but had to be creative in a safe manner to meet with clients through a virtual platform until in-person meetings could resume.

Green Chimneys has plans in place to meet with youth and their families virtually, while the current health crisis continues. Due to the limited amount of funding, Green Chimney will only be able to work with 7 youth.

The Putnam County Probation Department plans to use the money to conduct curfew checks on all the youth involved in the county's juvenile justice system during the pendency of court proceedings. The curfew checks are aimed to address the on-going needs of youth at risk and to remind them of their upcoming court dates. By conducting curfew checks we will be able to have additional oversight on these cases and support for families. Random visits to the home will increase accountability of the youth and their families, so these youth do not enter the juvenile justice system and or be placed in the detention system. Transportation will be provided for youth to probation and to services if needed.

The average length of service for these youth is high in number and the need for these youth to be supervised by Probation officers and to make sure they are following the rules and attending appointments is crucial. Transportation is a huge barrier in Putnam County, so providing transportation to and from appointments will help out these individuals.

The Adolescent Victim Services program will provide direct trauma informed services to adolescents using the Dialectical Behavior Therapy (DBT) which is an evidence based, cognitive-behavior approach that emphasizes the psychosocial aspects of treatment. This project will enhance the ability to provide direct trauma informed services to adolescent victims of violence who are at risk of potential involvement in the juvenile justice system.

Youth will attend individual and group therapy sessions that will address trauma, build renewed self-esteem, self worth and develop improved decision making skills to support them in the future. This program will be used to divert and to prevent the future progression of youth into the juvenile justice system.

This program will teach skills and provide opportunities for youth during the school day and after school and during the summer months. The goal is to reduce school drop out rates, school suspensions, truancy, and arrests. Middle school students will have access to attend school during the school day and the after school program and summer camp opportunities. Due to COVID Camp Herrlich is currently having students attend school from the camp.
