Dear Chief Executive Officer,

Thank you for submitting Seneca County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2021-2022. Your entire STSJP plan, including any amounts listed for PY 2021-2022 STSJP-RTA, has been **approved.**

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2022, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP

Once the shift is approved, an amended STSJP plan will need to be submitted.

As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2021 to September 30, 2022. Based on the data there was a total of 3 placed in detention during 2020. 2 youth were white caucasian non hispanic, and 1 youth was hispanic. There is a disparity, however the numbers are so low that no trends in disparity can be determined from such low numbers.

The Commissioner, Director of Services, Workforce Development Youth Bureau Director and Deputy Director for Youth Services and new Probation Director reviewed current program services, and if program provider changes we implemented last year improved the outcomes. The referral process was also reviewed and how we identify at risk youth and engage them into the youth development programs. The Criminal Justice Advisory Board members comprised of law enforcement, probation, service providers, court system personnel are included in discussions regarding the services available for the STSJP and RTA populations. Schools are involved indirectly through school student support teams held monthly with DHS and Probation staff a part of these teams.

During the 2020-2021 program year, Seneca County did not receive feedback for the STSJP plan Development. Cayuga Centers services will include Functional Family Therapy and Skill Building services to provide initial screening and on going assessments including but not limited to Casey Life Skills and the Columbia Risk Assessment. The referrals will be made through the Division of Human Services Department of Children and Family Services. The referral for Functional Family Therapy will provide diversion or adjustment for those youth initially charged as a juvenile delinquent or a PINS intake through the Probation Department. Initial intake will take place within one week. Weekly or Bi-weekly skill building customized to the youths' goals focused on enhancing existing strenghts. The skill builders will partner with parents/caregivers to help them best support their child to maintain and implement the learned skills. The skills based approach will use trauma informed practice as a treatment model lens. These services will take place in the home, school and community. This Early Intervention program working with the youth and family should help in reducing a youth being placed outside the home. The program serves the adjudicated youth population as an alternative to placement

The Boys to Men group serves youth ages 13 to 18 that have several risk factors for becoming a PINS or Juvenile Delinquent, including truancy, substance use or mental health concerns. Youth are referred through the Division of Human Services, Department of Child and Family Services, Probation, Youth Bureau, School personnel, Runaway Homeless Youth Program, school student support services committees and youth service agencies. The group curriculum focuses on communication, values, attitude, self esteem, abandonment, bullying, anger/violence, healthy relationships, divorce and separation. Many of the youth and staff have identified these areas of concern. This program can serve both STSJP/STSJP-RTA youth or who are receiving diversion/adjustment services.

There were youth that opted to attend from home, but did not participate.

 The referral source, Caseworkers, and probation officers will continue to engage youth to discuss if there are additional barriers preventing them from participation, and will work to address them so youth can participate.

Seneca County Community Counseling will provide mental health evaluation assessment and treatment as necessary for youth referred through the STSJP program. Youth referred through STSJP -Division of Human Services Departments, Probation or Cayuga Centers will receive priority appointments, and can be seen same day through the integrated clinic. The Early Intervention Program Services are available prior to detainment or residential placement. Mental Health services can be offered in office, at school, through telehealth and evening and weekends as necessary. Staff are trained in Trauma Informed treatment. Youth receiving mental health services/treatment in a timely manner in the community, will remain at home and reduce the number of youth who progress further in the juvenile justice system and ultimately may be detained or residentially placed.
