This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child's family; any extraordinary or pertinent information concerning the circumstances of the child's death; whether the child or the child's family received assistance, care or services from the social services district prior to the child's death; any action or further investigation undertaken by OCFS or the social services district since the child's death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child's household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child's siblings or other children in the household.**

OCFS' review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS' assessment and the performance of these agencies.

Presenting Information

A report was made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) on 11/03/2014, which alleged Inadequate Guardianship, and DOA/Fatality against the father on behalf of the three-month-old male subject child. This report alleged that the father and the subject child fell asleep on the couch, and the father suffocated the subject child by rolling on top of him. The mother was at work at the time of the incident and therefore had no role in the case. The police were notified and the subject child was taken to the local hospital where he was pronounced dead on arrival. The situation was being investigated by police.

Executive Summary

Dutchess County Department of Social Services, (DCDSS), conducted an investigation into the allegations, and coordinated their investigation with law enforcement. Appropriate collateral contacts were made, and pertinent information was obtained. DCDSS contacted medical professionals, first responders, family members and friends, as well as community resources for services for the family.

There are no surviving siblings and all Assessments as well as the Risk Assessment Profile (RAP) were appropriate, timely, and accurately reflected the known circumstances of the case.

On 12/22/2014, DCDSS made the determination to substantiate the allegations listed on the report. The basis for the determination was the failure of the father to utilize an appropriate sleeping arrangement for the subject child. The home was also noted to have a safe and appropriate crib for the subject child, which was not utilized at the time of the incident. The father also lied to the police initially stating that both he and the subject child were on the bed when, in fact, the incident occurred on the couch. The father was also taking prescribed medications with side effects that included drowsiness, while caring for the subject child. There were also multiple prescription bottles in the home with medications prescribed to the father. The father also admitted to taking medications prior to coming to the hospital and was observed by a police officer to be "popping [the medication] like tic tacs."

Pediatric records indicated no health concerns in regard to the subject child. The Medical Examiner noted no visible signs of trauma, and ruled the manner of death an accident with the cause of death being Asphyxia due to suffocation (wedged against a couch cushion).
