This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

On 7/4/16, the SCR received a report that the 2 month old SC died while in the care of his BF. The BM went to work, leaving the SC in the care of his BF, who laid down to take a nap with the SC in a an adult bed. The bed contained pillows and blankets, as well as other items. The BF woke up from his nap and found the SC to be blue and unresponsive. EMS was contacted and responded to the scene along with LE. The SC was transported to the local hospital, but life saving attempts were unsuccessful.

Executive Summary

On 7/4/16, the BM left for work, leaving the SC in the care of the BF. The BF laid down with the SC in a an adult bed to take a nap. The adult bed contained pillows, blankets, clothing and other miscellaneous items. The BF woke up and checked on the SC, and found the SC unresponsive. 911 was called and EMS and LE responded to the scene. The SC was transported to the local hospital, and was pronounced deceased. The LDSS coordinated the investigation with LE and with the ME. The LDSS CW made numerous face to face contacts with the BM and BF, as well as family members and others present on the date of the fatality. The LDSS CW made adequate collateral contacts in order to gather sufficient information to make a determination in this case. The LDSS determined that the BM did not have a role in this case, as she was not home at the time of the fatality and left the SC in the care of the BF. The BF placed the child in an unsafe sleep environment, and following an examination, the ME determined that the cause of the SC's death was "sudden death related to an unsafe sleep environment". Though the manner of death was listed as "undetermined", the BF admitted to lying down with the child in the unsafe sleep environment, the LDSS worker and LE's documentation of the sleep environment was consistent with the BF description and the SC did not have any other conditions that would have contributed to her death. The LDSS substantiated the allegations of IG and DOA/Fatality for abuse against the BF. There were no surviving siblings and the case was closed.

LDSS Response

Once the LDSS was aware of the child fatality, the LDSS CW coordinated the investigation with LE and the ME and made adequate collateral contacts with the SC's pediatrician, emergency personnel and hospital personnel. The LDSS also made multiple visits to the home to interview the BF and BM along with other family members and people present on the date of the incident. The LDSS was able to determine that the BF laid down in an adult bed with the SC, with a number of pillows, blankets, clothing, a remote control and various other items. The BF woke up from his nap to find the SC unresponsive and EMS was called. The SC was transported to the local hospital. Following the fatality, the ME reported the cause of death as "Sudden death associated with unsafe sleep environment". The BF admitted to sleeping with the SC. The BM received Safe Sleep education, but it is unclear if the BF had received Safe Sleep education prior to the SC's death. The LDSS substantiated the allegations of IG and DOA/Fatality against the BF for abuse and closed the case. The SC did not have any siblings, and the LDSS CW offered the BM and BF grief counseling/mental health services and financial assistance for the burial arrangements and the case was closed.
