This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

Oneida County Department of Social Services (OCDSS) received a report from the SCR alleging that on 3/7/22, at 5:20PM, the 6-month-old subject child was found unconscious in a bedroom. The mother had no explanation for the child's death. The father was at work at the time that the mother was caring for the subject child and 3-year-old sibling. At around 3:30PM, the mother put the child upstairs in the bedroom in a regular-sized bed. Around 4:00PM, the mother checked on the child and she appeared fine. The mother checked on the child again at 5:20PM and found she had rolled onto her stomach and was not breathing. The mother notified the father and he returned home from work. Upon his return home, the father called 911. First responders arrived and transported the child to the hospital where she was pronounced dead.

Executive Summary

This report concerns the death of the 6-month-old female subject child that occurred on 3/7/22. At the time of the subject child's death, she resided at home with her mother, father, and 3-year-old sibling.

The investigation revealed that on 3/7/22, the mother was home with the subject child and sibling while the father was at work. The mother bathed the subject child around 2:30PM and then prepared a five ounce bottle of formula. The child was placed down for a nap on a queen-sized bed shortly after 3:00PM. The record revealed the child was placed on her back with a propped bottle. Around 5:00PM, the mother checked on the subject child and found her lips were blue and she was not breathing. The mother called the father, who called 911 and returned home from work. First responders arrived at the home and began CPR and transported the child to the hospital where she was pronounced dead.

An autopsy was completed and listed the cause of death as unexplained sudden death (intrinsic and extrinsic factors identified). The manner of death was undetermined. The medical examiner's report revealed the subject child was a healthy infant born at 39 weeks with no medical complications. The report further stated the family had a viral infection in January 2022 and the decedent had a fever and positive test postmortem for the infection. The medical examiner found no anatomic finding to exclude the possibility of a component of an unsafe sleeping environment contributing to the death.

At the time of this writing, the investigation remained open as there were additional progress notes to be input. The mother and father were receptive to fatality related services and the record revealed OCDSS provided information on bereavement services. OCDSS coordinated efforts with their multidisciplinary team and the law enforcement investigation was closed, finding no criminality.

LDSS Response

On 3/8/22, OCDSS received the SCR fatality report regarding the subject child. Upon receipt of the fatality report, OCDSS initiated their investigation within 24 hours and coordinated efforts with their MDT. OCDSS reviewed CPS history which revealed that neither the parents, subject child, nor sibling were known to the system.

OCDSS interviewed the mother and father upon receipt of the report. Due to a language barrier, OCDSS enlisted the Language Link interpreting service. The mother reported she was home with the subject child and sibling on 3/7/22 while the father worked. The subject child had recently begun eating a rice cereal mix and the mother provided that to the subject child prior to giving her a bottle of formula at 3:00PM. The mother placed the subject child into the parents' queen-sized bed shortly after 3:00PM. The mother reported there was a bassinet accessible to the child but due to the subject child learning to roll over, the mother believed it was safest to place her on the adult-sized bed. The mother placed the child on her back in the bed with a bottle propped. The mother reportedly checked on the subject child around 5:00PM and found the child had rolled onto her stomach and was unresponsive. The mother called the father who immediately left work and called 911. First responders arrived at the home around 5:25PM and began resuscitation efforts before transporting the child to the hospital where she was later pronounced dead. Both parents denied knowledge of safe sleep practices regarding children being safest alone, on their backs, in a crib; but were aware to place the child on her back to sleep.

The sibling was assessed to be safe in the care of the parents. No safety concerns were revealed for the sibling as the



unsafe situation was isolated to the circumstances of the subject child’s vulnerability. OCDSS assessed safety of the sibling within 24 hours of receipt of the report. Appropriate fatality-related services were offered to the family. The investigation remained open at the time of this writing.
